ACP will create sessions featuring 3-5 *Clean Power Insights*, which are fast-paced and dynamic presentations. These sessions will feature back-to-back high-energy presentations (think TED Talks for approximately 10 minutes each) delivered by a single speaker presenting from center stage using the most relevant / minimal graphics and videos (5 slides max). These talks are flashy, cutting-edge and future focused, featuring the best-of-the-best speakers to share insights, strategies, stories, or solutions on a specific topic. Similar talks will be bundled together to create sessions under a related topic or theme.

Poster Presentations

Poster Presentations provide a visual and interactive platform for presenting research, projects, or ideas and allow for informal, yet substantive, exchanges of information. Poster sessions showcase a variety of topics, provide direct engagement with attendees and facilitate networking and collaboration. Posters will be presented during a poster reception at the conference. Additionally selected speakers will be given a 10-minute speaking time during the conference.

Speaker Criteria:

As part of the review process, ACP will assess speakers along the following criteria:

Industry Experience: Preferred speakers should have a minimum 5 years of experience in the clean energy industry.

Specialized Knowledge: Demonstration of expertise in a specific area of specialty within the industry.

Leadership Role: Professionals in senior roles are preferred.

Presentation Experience: Prior experience presenting at industry conferences or virtual programs will be considered.

Engaging Speaker: Ability to communicate complex technical concepts in an engaging and accessible way for diverse audiences.

Clarity in Communication: Speakers must be able to effectively articulate best practices, innovations, and key takeaways.

Timely and Innovative Content: Presentations should offer fresh perspectives, innovations, or practical insights that address current challenges in the industry.

Reputation: A positive reputation within the industry for advancing the clean energy industry.
